FLOOR 09 - OEMC FIRE PLAN



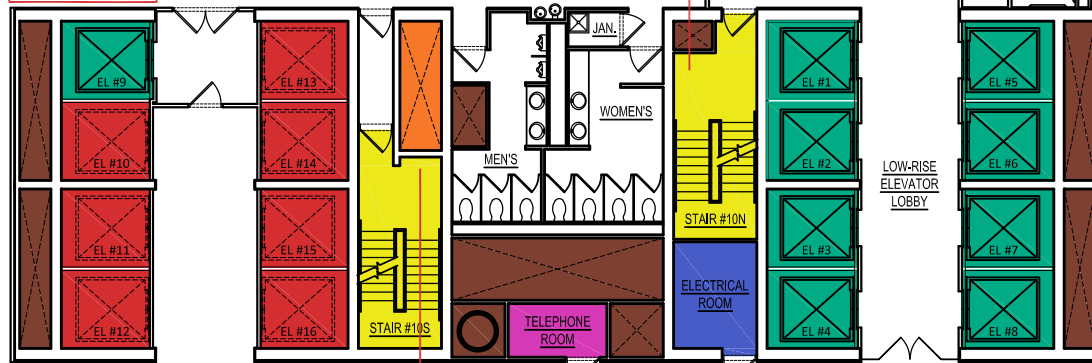
