FLOOR 10 - OEMC FIRE PLAN

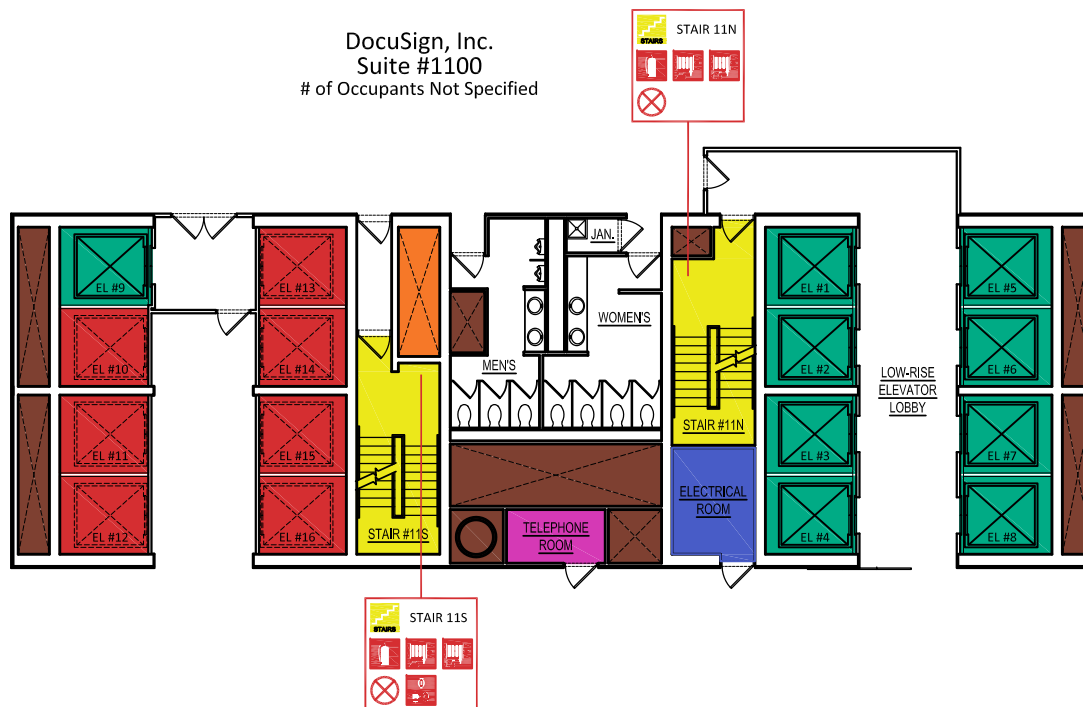
